

Privacy Policy & Cookie Policy

We at Cointelegraph.com ("we", "us", "Website" or "Cointelegraph") respect your privacy. This Privacy Policy ("Policy") applies to personal and customer information ("information") obtained by Cointelegraph through our Website, as well as our web browser extension Cointelegraph – Blockchain & Ethereum News or any other source to which this Policy is linked or referenced.

The Policy describes the types of information we obtain about visitors of our Website ("You", "Your") and how we use said information. We also describe the measures we take to protect the security of the information and how you can contact us about our privacy practices.

For the purpose of the General Data Protection Regulation 2016/679 and any implementing legislation (the "GDPR"), we will be the data controller responsible for any personal data we process.

1. Types of Information We Obtain

1.1. Non-personal Information:

1.1 (a) When you visit Cointelegraph.com, our system obtains information regarding your use of our Website through automated means, including, but not limited to, web server logs, JavaScript, and similar technologies.

1.2. Personal Information:

1.2 (a) We may obtain your personal data from the following sources:

- i) from you directly (through the website or online forms); and/or
- ii) from third parties, service providers that are assisting us in providing you with a service, or from your social networks accounts you used to sign in to our online services.

1.2 (b) By voluntarily providing us with personal information, including, without limitation, by using the Website, you expressly and irrevocably agree to our use of your personal information in accordance with this Privacy Policy. If you provide personal information to us, you acknowledge and agree that such personal information may be transferred from your current location to the servers of the Website and to the servers of authorized third parties unless it is permitted by the applicable law.

1.2 (c) We may collect the following categories of personal data relating to our existing or prospective individual visitors:

- a) Contact information;
- b) Your IP address and unique mobile device identification numbers (such as your device ID, advertising ID, MAC address);
- c) Data about your device, such as manufacturer, operating system, browser type, and language;
- d) Broad location data;
- e) Precise geolocation data;
- f) Data we collect with cookies and similar technologies;
- g) Data we receive if you link a third-party tool with the Service (such as Facebook, Google,

or Vkontakte);

h) Data for advertising and analytics purposes, so we can provide you a better Service;

i) Your messages to the Services (such as any feedback you submitted about your experience);

j) Information on the use of our website (for example, pages visited, geographical location, time spent on the website, online transactions);

k) Preferences regarding online marketing; and/or

l) Other data you choose to give us.

1.3. Additional Information:

1.3 (a) From time to time, we reserve the right to obtain information about legal entities that visit our Website through their representatives.

1.3 (b) We may obtain information about the website of a legal entity, the name of the legal entity, the contact information of the legal entity, including business emails, the country of incorporation, and the link to the ICO of the legal entity (if applicable).

1.4.

We may use our web browser extension to obtain information described in this Policy. Our web browser extension can only access specific information that you have explicitly granted permission to access. We cannot and do not track your browsing history.

2. How We Collect Information

2.1. We may collect personal identification information such as your email and name from you only if you voluntarily submit such information to us. You can always refuse to supply personal identification information. We may collect non-personal identification information about you whenever you interact with our Website.

3. How We Use the Information We Obtain

3.1.

We use non-personal information for the following purposes:

(a) to prevent you from seeing unnecessary advertisements or requiring you to re-enter the Website more than is necessary;

(b) to calculate the aggregate number of people visiting our Website and which parts of the Website are most popular;

(c) to improve the content of our web pages and to customize the content and layout of our pages;

(d) to deliver the information you request from the Website, such as an article, news, review, analysis, etc.

3.2.

Areas in which we may use your personal information include, but are not limited to, providing you with email newsletters, feedback, and especially the ability to comment on articles and interactive forms. If you provide us with your email address, you may receive periodic promotional emails from us and carefully selected partners with information regarding special offers or services in case you provide consent for such actions from our side. You may also receive informational emails from us related to administrative notices regarding the operation of the Website. You may at any time withdraw your consent to receive electronic advertising emails by sending a withdrawal notice to Cointelegraph or by pressing the dedicated button ("an unsubscribe button") in any email from Cointelegraph.

3.3.

We may share your information with the following types of third parties:

- a) technical support providers who assist with our website and infrastructure;
- b) third-party software providers, where the provider hosts the relevant personal data on our behalf;
- c) professional advisers such as solicitors, accountants, tax advisors, auditors, and insurance brokers;
- d) providers that help us generate and collate reviews in relation to our goods and services;
- e) our advertising and promotional agencies carrying out our marketing campaigns on our behalf and to advertise their own products or services that may be of interest to you; and/or
- f) service providers that assist us in providing our services.

3.4.

We may share your information with law enforcement or government bodies.

We may disclose your personal data as permitted by law in order to investigate, prevent, or take action regarding illegal activities, suspected fraud, violation of our intellectual property rights, situations involving potential threats to the physical safety of any person, violation of our agreements, or as required by law.

4. Cookies

4.1.

Cookies are files with a small amount of data that may include an anonymous unique identifier. Cookies are sent to your browser from the Website and stored on your computer's hard drive.

4.2.

Like many websites, we use "cookies" to collect information. We use cookies on our Website to collect data about your visit and to allow you to navigate from page to page, count visits, and see which areas and features of our Website are popular. This helps us to gather feedback in order to constantly improve our Website and better serve our customers.

Cookies do not allow us to gather any personal information about you, and we do not generally store any personal information that you provided to us in your cookies.

4.3.

You can control and/or delete cookies if you wish. You can delete all cookies that are already on your computer, and you can set most browsers to prevent them from being stored therein. If you do this, however, some services and functionalities of our Website may not work.

5. Data Retention

5.1.

We will retain your information for as long as is needed to provide you services or as required to fulfill our legal obligations. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

5.2.

By contacting us at GDPR@cointelegraph.com, you can at any time obtain confirmation of whether or not personal data concerning you is being processed.

5.3.

You have the right to access and export your information at any time by sending a request to GDPR@cointelegraph.com.

6. Privacy Complaints

6.1.

To the extent that our processing of your information is subject to the EU General Data Protection Regulation, we rely on our legitimate interests, described above, to process your data. You have a right to object to our use of your information for our own marketing purposes at any time by clicking on the special button and opting out from receiving all emails. You may also object to processing by emailing GDPR@cointelegraph.com.

6.2.

We take privacy concerns seriously. If you believe that we have not complied with this Privacy Policy with respect to your information, you may contact our Data Protection Office at GDPR@cointelegraph.com. In your message, please describe in as much detail as possible the ways in which you believe that the Website's Privacy Policy has not been complied with. We will investigate your complaint promptly and will reply to you within 30 days.

7. How We Protect Personal Information

7.1.

We maintain administrative, technical, and physical safeguards designed to protect the personal information we have about you against accidental, unlawful, or unauthorized destruction, loss, alteration, access, disclosure, or use.

7.2.

We have put in place appropriate security measures to prevent your data from being accidentally lost, used, or accessed in an unauthorized way, altered, or disclosed. In addition, we limit access to your data to those employees, agents, contractors, and other third parties who have a business need to know. They will only process your data on our instructions and are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected data breach and will notify you and the competent regulator of a breach where we are legally required to do so.

8. How Long Do We Keep Your Personal Data?

8.1.

We will keep your personal data only for as long as is necessary for the purposes for which it was collected in connection with your requests via our website or your use of our website.

9. Third-Party Links

9.1.

Occasionally, at our discretion, we may include or offer third-party products or services on the Website. These third-party providers have separate and independent privacy policies. We, therefore, have no responsibility or liability for the content and activities of these linked services. Nonetheless, we seek to protect the integrity of our Website and welcome any feedback about these services.

10. Analytics

10.1.

To determine how many persons visit our Website and to better understand the areas of greatest interest to our visitors, we reserve the right to have relationships with web analytics companies that compile this information for us. For further information, consult the privacy

11. Changes to the Privacy Policy

11.1.

This Privacy Policy may be updated periodically and without prior notice to you to reflect changes in our personal information policies. For significant changes, we will notify you by posting a prominent privacy policy on our Website indicating at the top of the Policy when it was most recently updated.

12. Children

12.1.

We do not intend to solicit or collect Personal Information from anyone under the age of 16 or under the legal age of your country, if it is higher. If you are under 16 or are not of a legal age of your country, you shall not provide Personal Information on this Site.

13. Your Rights

13.1.

You are entitled to obtain information from us on how we handle your personal data, to see copies of all personal data held by us, and to request that your personal data is amended, corrected, or deleted from our systems. You can also limit, restrict, or object to the processing of your data. We do not carry out any decision-making based solely on automated processing, including profiling.

If you gave us your consent to use your data, you can withdraw your consent at any time. Please note that even if you withdraw your consent, we can still rely on the consent you gave as the lawful basis for processing your personal data before you withdrew your consent.

You can object to our use of your personal data where we stated we rely on our legitimate business interests to do so.

13.2.

If you want to request that we no longer use and process your information to provide you services as well as withdraw your personal data, please write to us at GDPR@cointelegraph.com. We will respond to your request within 30 (thirty) days.

14. Law and Harm

14.1.

Notwithstanding anything to the contrary in this Policy, we may preserve or disclose your information if we believe that it is reasonably necessary to comply with a law, regulation, legal process, or governmental request; to protect the safety of any person; to address fraud, security, or technical issues; or to protect our or our visitors' rights or property.

14.2.

Cointelegraph may share your personal information with law enforcement, data protection authorities, government officials, and other authorities when Cointelegraph is legally bound to do so or to protect the safety of visitors and Cointelegraph.

We also ensure in our contracts with these organizations that they only process Personal Data in accordance with our instructions and in order to provide the agreed services and protect the integrity and confidentiality of your personal data entrusted to them.

We may also disclose personal data to our advisers, consultants, law enforcement, and other public authorities (such as tax and social security bodies), the police, prosecutors, courts, and tribunals. All these recipients are themselves responsible to comply with the EU data protection rules.

17. Rights of Use
